

NAVIGATING THE CERTIFICATION APPLICATION PROCESS

- Step 1: Complete and submit the “Application for Municipal Building Official Certification” with the \$50 fee
- Application must be filled out completely, signed, and dated
 - Education, certifications, experience, and employment pages must be filled out in detail and include supporting documentation such as college transcripts, ICC certifications, and employment verification letters
 - A minimum of 100 qualifying points is required for your application to be approved

- Step 2: [Schedule your exam online](#) once you receive an approval letter with an exam application number (instructions provided in the approval letter)

Building Official, Limited Certification

- Step 1: Complete and submit the “Application for Municipal Building Official Certification” with the \$50 fee
- Application must be filled out completely, signed, and dated
 - Education, certifications, experience and employment pages must be filled out in detail and include supporting documentation such as college transcripts, ICC certifications and employment verification letters
 - A minimum of 30 qualifying points is required for your application to be approved

- Step 2: Submit the Course Enrollment Form along with your application - there is no fee for the course
- Enrollment form must be filled out completely.

 - Indicate which course dates you want to enroll in
 - If you have taken this course previously, you may waive enrollment in the course again by checking the box on the form and submitting it with your application
- Step 3: After attending the entire course, or waiving enrollment, you can [schedule your exam online](#) when you receive an approval letter with an exam application number

Accessibility Specialist Certification

- Step 1: Submit an “Application for Municipal Building Official Certification” with the \$50 fee
- Application must be filled out completely, signed, and dated

 - Qualifying points are not required for your application to be approved
