#### Unlicensed contractor fined \$24,500

- An unlicensed contractor operating out of Browerville and Long Prairie, Minnesota, was found to have engaged in residential remodeling work without a license. The contractor was ordered to cease and desist from the unlicensed activities and fined \$24,500.
- An Arkansas contractor was found to have engaged in unlicensed electrical work. The contractor was ordered to cease and desist from the unlicensed activity and fined \$7,500.



- An unlicensed Shakopee, Minnesota, contractor was found to have engaged in plumbing and electrical work without having the appropriate contractor licenses. The contractor was ordered to cease and desist from the unlicensed activity and fined \$4,000, which was stayed contingent on future compliance.
- A licensed Golden Valley, Minnesota, residential building contractor was found to have breached contracts with multiple homeowners, demonstrating financial irresponsibility. DLI revoked the contractor's business license and assessed a \$10,000 fine.
- A licensed Woodbury, Minnesota, residential building contractor was found to have breached contracts with multiple homeowners by failing to complete projects after receiving payments. DLI revoked the contractor's license and assessed a \$30,000 fine, which was stayed contingent on full future compliance and full cooperation with homeowners seeking to apply for potential reimbursement to the Contractor Recovery Fund.





Where it all started


- In September of 2021, the electrical supervisory staff for the department began looking at the feasibility of performing virtual electrical inspections.
- The supervisory staff reached out to several other states and jurisdictions to help gauge the benefits of starting a virtual program and to help avoid any pitfalls that others may have experienced.
- Along with virtual inspections, it became clear that the best path forward was to transition the contract electrical inspector positions to state-employed positions, to make the virtual program more flexible.
- By early spring of 2022, the process had begun and the preliminary steps to assemble the team started. 2

#### The launch of state and virtual inspections

- July of 2022, two field inspectors were hired.
- September 2022, Jason Ekholm was hired to be our virtual inspector. The first state virtual inspections were done on Sept. 19, 2022, in state inspection areas.
- November 2022, we added another field inspector in northwest Minnesota, for Polk and Red Lake counties, which further expanded our outreach and virtual inspection program.






#### Getting the word out


- We began working on filming with an outside vendor to complete a couple of short introductory videos.
- DLI's communications team sent out notifications to our stakeholders informing them of the virtual program start up, in designated areas.
- Marketing emails about our ERVI program were sent to electrical contractors who worked within the designated inspection areas over the past two years.

#### 2022 ERVI was slow to start

- Initially, virtual inspections were very much a manual effort. Contractors would contact our virtual inspector to schedule a Microsoft Teams call to conduct their virtual inspection.
- The first month only about 40 inspections were completed virtually.
- By the end of 2022, we were completing over 100 virtual inspections per month.
- With the increased workload, it became clear that the manual actions that Jason was completing for each inspection was not efficient nor sustainable.
- We began discussing a scheduling component for iMS, to help automate the process.







#### The future of the program 2024


More areas will be converted to state employee inspection areas:

- By July we will convert an additional 20 areas over to state-employed inspections.
- Along with hiring additional field staff, there will be a need to increase the number of virtual inspectors.
- We looked for solutions that would allow a more user friendly and automated method of scheduling and conducting virtual inspections.









- The inspection transition will be complete, with all state-inspected areas being completed by state employees.
- Virtual inspections will be offered statewide.
