1. Call to order

- A. Chair Metz called the meeting to order at 9:30 a.m.
- B. Roll call was taken by Ryan Rehn (chair alternate) and a quorum was established with 18 members present in person or via WebEx. A quorum was maintained throughout the meeting.
- C. Announcements/Introductions Chair Metz
 - Welcome new/re-appointed members:
 - o Arlen Grant, new member, Licensed Professional Engineer
 - o Mike Paradise, re-appointed, Licensed Residential Building Industry
 - Barry Grieve, re-appointed, Commercial Building Owners/Managers
 - Everyone present in person and remotely can hear all discussions.
 - All votes will be taken by roll call if any member is attending remotely.
 - All handouts discussed and WebEx instructions are posted on the Council's website.
- D. WebEx instructions/procedures were read aloud.

2. Approval of meeting agenda

A motion was made by Jenson, second by Brunner, to approve the agenda as presented. The roll call vote was unanimous with 18 votes in favor; the motion carried.

3. Approval of previous minutes

A motion was made by Guth, seconded by Landry, to approve the Nov. 8, 2023, meeting minutes with the removal of Greg Metz under Staff & Visitors. The roll call vote was unanimous with 18 votes in favor; the motion carried.

4. Regular business

Expenses were approved.

5. Department update

Deputy Commissioner Perushek summarized legislation impacting the Department.

6. Division update – see <u>presentation</u>

- A. Grants Program Greg Metz
- B. DLI Rulemaking
 - a. Adult-sized changing facilities Karen Gridley
 - b. Electric vehicle charging facilities for commercial buildings Greg Metz
 - c. Window cleaning safety Greg Metz
 - d. Residential Energy Code TAG Steve Shold
 - Representative Kraft summarized the proposed language for Residential Energy Code reform – see <u>presentation</u>, slide 31
 - Chair Metz said the 2038 residential energy conservation legislative goal baseline is based on the 2006 IECC document. The 2006 IECC is based on the same grounding as the Commercial Energy Code criteria, the 2004 ASHRAE 90.1 document. It is good that the same baseline is being used for both commercial and residential construction. The 70% reduction from that baseline essentially gets us to net zero ready residential construction efficiency for Minnesota by 2038 without requiring energy production required for actual net-zero. DLI statutorily does not have the authority to require energy production onsite.
 - Rep. Kraft said there is one more part of the Bill about a rebate program that they're trying to put in place but will be subject to budget. This is for those who

want to go to that zero energy ready now – there is funding from the federal government, from the IRA, a \$5,000 per unit rebate for developers. There's a cost to get one's property certified so this would cover that cost in a rebate program. Right now, it is written to be administered by DLI but they're looking to change this to Commerce.

- Landry clarified that the site energy doesn't consider plant efficiency. It's just energy use at the site. There will be source energy that considers the grid efficiencies and so forth.
- Rep. Kraft summarized HF 4241, Statewide Building Code enforcement see presentation, slides 33 & 34.
- Rep. Kraft summarized HF 3351, Single Stairway Apartments as follows:
 - Municipal fire department must have the equipment to access every emergency escape and rescue opening (egress window) on the building from the lowest level of fire department access.
 - o If buildings have zero setback on the sides and an alley on the back, then if there are egress windows on the back/alley side, those too must be able to be safely reached by the municipal fire department from the lowest level of fire department access. Sometimes alleys get tight, and the fire equipment needs to deploy outriggers and also be able to maintain a minimum slope on the ladder to climb it safely.
 - Separation between dwelling unit entries and the stairwell so that apartment doors can't be propped open and compromise the stairways.
 - Minnesota would be the second state to adopt/allow this after Washington State.
 - Concern regarding firefighter safety and occupant safety with occupants
 trying to go down the stairs when firefighters are trying to go up. Code
 minimum stairways do not accommodate this congestion because it
 assumes at least two stairways that firefighters will be going up the stairway
 closest to the fire and occupants go down stairways more remote to the fire.
 Stairways are one-way traffic.
 - Should consider emergency egress situations other than fires, like active shooter incidents. Fire is not the only reason to evacuate a building.
 - Very concerned about taking away a means of egress. Many points were brought up regarding residents setting trash in corridors, blocking doors, propping doors open, two-way traffic in the stairwells, and almost no room to pass in the stairway. TAG should consider requiring wider stairways to accommodate two-way traffic during emergencies with firefighters wearing and carrying their equipment. TAG should consider requiring trash chutes so that trash is not carted up and down the elevator or stairway or left in corridors because bringing the trash down would be too much work.
 - Elevators should be required. Requiring elevators will ensure that the buildings meet the minimum accessibility requirements and provide more equitable housing in the form of Type B units. Would also include requirements for two-way communications systems.
 - Elevators should be sized to accommodate stretchers for emergency response teams.

- Consider requiring some "missing middle" housing by requiring some of the dwellings on each floor to be more than 2-bedrooms. Discuss this in the context of the current overall housing shortage.
- This statute will require a separate TAG after the 1305 primary TAG to convene in the fall if the bill passes, and then incorporate into the overall 1305 changes for implementation in 2026.

7. Regular business – Greg Metz, Chair

- A. Legislative update
 - a. Proposed Point Access Blocks single egress stairway
 - b. Proposed EV charging requirements for all residential construction
 - Representative Rehm summarized proposed Bill HF3439 see <u>presentation</u>, slide 30.
 - Greive asked if DLI has looked at the work done last year on EV charging and the proposed rules to see how this would affect that.
 - Chair Metz said they have not specifically addressed this Bill because it was
 presented after the Technical Advisory Group had completed their work.
 However, he doesn't see that this would impact that work because essentially
 fewer than four dwelling units, such as triplexes, would likely fall under the
 residential energy code anyway.
 - Greive asked what definitions would be used for commercial and multi-family structures. It also says that all new residential buildings that provide on-site parking – this could mean a single-family home with a driveway.
 - Chair Metz said that is correct and he believes this is the intent of this bill, single-family residential dwellings. Staff's recommendation is to accept this as an amendment to the MN Electrical Code, so it would apply throughout the state of Minnesota. It is primarily an electrical requirement at this point so it would not land in the Energy or Building Code. The department typically does not amend the Electrical Code.
- B. Well contractors seeking statutory authority to design water service piping from well to pressure tank
 - Plumbing Board is currently working on rulemaking.
- C. Existing buildings energy performance criteria off the table this session
 - This was discussed in a previous meeting regarding DLI incorporating some existing building performance criteria into the energy codes this is a pretty heavy lift, essentially building performance standards. Nationally, the way that building performance standards are unfolding and developing is that they measure the energy use of existing buildings. So, it includes both building envelope use, HVAC, service water heating, and plug loads. Because the whole plug load piece is outside of our jurisdiction, we can't do building performance standards through DLI, through Minnesota Statute 326B. So, Congress is taking this on, they have a statute that's been approved for them to be able to take this on, and they're in the process of unpacking a building performance standards program and criteria for that moving forward. So, that will come off our plate.

- D. Building resiliency scoping addition to the State Building Code off the table
 - Metz said he pitched trying to add building resiliency scoping to the State Building Code this year; however, they are not moving forward this year. He will continue to study this and take another run at this next year.

 A motion was made by Jenson, seconded by Abrahamson, to approve the
 Technical Advisory Group with the addition of Barry Greive. The roll call vote was
 unanimous with 17 votes in favor; the motion carried. (Marie-Alves no response).
- MN Rules Chapter 1307 Elevators
 A motion was made by Ubl, seconded by Barnett, to approve the Technical
 Advisory Group as presented. The roll call vote was unanimous with 18 votes in favor; the motion carried.
- d. MN Rules Chapter 1309 Residential Building Code and
- e. MN Rules Chapter 1309 Residential Building Code Mechanical Provisions

 A motion was made by Grant, seconded by Abrahamson, to approve the Technical Advisory Group as presented. The roll call vote was unanimous with 18 votes in favor; the motion carried.

- f. MN Rules Chapter 1311 Conservation Code for Existing Buildings
 A motion was made by Greive, seconded by Ubl, to approve the Technical
 Advisory Group as presented. The roll call vote was unanimous with 17 votes in favor; the motion carried.
- g. MN Rules Chapter 1323 Commercial Energy Code (ASHRAE 90.1-2022) **Technical Advisory Group will be formed at a later date.**
- h. MN Rules Chapter 1341 Accessibility Code
 A motion was made by Barnett, seconded by Landry, to approve the Technical
 Advisory Group as presented. The roll call vote was unanimous with 17 votes in
 favor; the motion carried.
- MN Rules Chapter 1346 Mechanical & Fuel Gas Code
 A motion was made by Grant, seconded by Guth, to approve the Technical
 Advisory Group as presented. The roll call vote was unanimous with 17 votes in favor; the motion carried.
