Licensing/ENF Update 1

Building contractor fined \$9,000 for performing electrical work

 An Elko New Market contractor was found to have performed electrical work without being licensed. The contractor was ordered to cease and desist from the unlicensed activity and fined \$9,000.



- A St. Paul contractor was found to have performed unlicensed plumbing work. The
 contractor was ordered to cease and desist from the unlicensed activity and fined \$3,500,
 which was stayed contingent on full future compliance.
- A New London contractor was found to have performed plumbing, electrical and remodeling work without
 having the required contractor licenses and bonding. The contractor was ordered to cease and desist
 from the unlicensed activities and fined \$15,000, of which \$11,000 was stayed contingent on full future
 compliance.
- An Owatonna contractor was found to have engaged in residential remodeling activities without having the required license. The contractor was ordered to cease and desist from the unlicensed activities and fined \$5,000, of which \$4,000 was stayed contingent on full future compliance.
- A licensed residential building contractor operating out of St. Paul was named a judgment debtor based upon conduct requiring licensure and was unable to satisfy multiple judgments. The contractor was ordered to cease and desist from acting as a residential building contractor and its license was revoked. A \$25,000 fine was assessed, which was stayed contingent on full future compliance.
