  - The discharge piping serving a temperature relief valve, pressure relief valve, or combination of both shall have no valves, obstructions, or means of isolation and be provided with the following: (1) Not less than the size of the valve outlet and shall discharge full size to the flood level of the area receiving the discharge and pointing down. (2) Materials shall be rated at not less than the operating temperature of the system and approved for such use or shall comply with ASME

A112.4.1.(3) Discharge pipe shall discharge independently by gravity through an air gap into the drainage system or outside of the building with the end of the pipe not exceeding 2 feet (610 mm) and not less than 6 inches (152 mm) above the ground and pointing downwards. (3) discharge independently by gravity through an air gap to a safe place of disposal or within 18 inches of the floor. Relief valve drains shall not terminate in a building's crawl space; (4) Discharge in such a manner that does not cause personal injury or structural damage. (5) No part of such discharge pipe shall be trapped or subject to freezing. (6) The terminal end of the pipe shall not be threaded. (7) Discharge from a relief valve into a water heater pan shall be prohibited. (8) The discharge termination point shall be readily observable.
