 - a. RFA PB0161 Karl Abrahamson (Chapter 3)
 - Feb. 7, 2024: Abrahamson pulled RFA will research and re-submit
 - b. RFA PB0163 Scott Thompson (Section 420.4)
 - March 6, 2024: Committee unanimously agreed to leave as amended in the 2020 MN Plumbing Code.
 - c. <u>RFA PB0164</u> Lew Anderson (Section 205.0, 407.3, Table 702.1, 704.3)
 - June 5, 2024 reviewed with Chapter 7: Lew Anderson, City of Minneapolis, summarized his RFA see Committee's recommendations shown below.
 - Committee accepted as presented:
 - Under section 205.0 in the definitions, add entry for "Commercial Hand Wash Sink" – with a suggested definition of: "A sink in a commercial kitchen or food service area which is primarily used for hand washing."
 - Committee accepted as presented with the following revisions:
 - Table 701.2 In Table 702.1, under sinks, add new line item entry for "Commercial hand wash" directly below the existing entry for "Commercial pot or scullery" - assign to "Commercial hand wash" a minimum size trap and trap arm of 1-1/2", assign footnote 2 for a 2" drain, assign 1.0 2.0 DFU under both the columns of Public and Assembly.
 - Committee accepted as presented:
 - Under Section 407.3, revise first paragraph to read: 407.3
 Limitation of Hot Water Temperature for Public Lavatories and Hand Wash Sinks. Hot water delivered from public-use lavatories and commercial hand wash sinks shall be limited to a maximum temperature of 110 degrees Fahrenheit (43 degrees Celsius). The maximum temperature shall be regulated by one of the following means:
 - Committee did not accept recommended language and instead agreed to leave 704.3 as amended in the 2020 MN Plumbing Code.
 - d. RFA PB0165 Lew Anderson (Section 311.1)
 - April 30, 2024: Committee stated they will review language at a later date and building code experts will be involved in the meeting discussion.
 - Proposed language for section 311.1, revise second paragraph to read:
 Every building shall have its own independent water and sewer connection services except that a group of buildings may be connected to one or more sewer manholes on the premises that are constructed to standards set by the Authority Having Jurisdiction. Water and sewer piping shall not be routed below or though one townhouse unit to serve another townhouse unit.
