

Quick reference guide: Rehabilitation provider registration

As of June 30, 2025, Work Comp Campus users will notice changes to the input screen for the registration and renewal of qualified rehabilitation consultants (QRC), QRC interns, QRC firms and rehabilitation vendors. While the process remains the same, there are changes to be aware of on the registration details page.

Updates to initial registration and renewal information are as follows:

QRCs and QRC interns

- An affirmation that the applicant has Minnesota residency or residency within 100 miles by road from the Minnesota border.
- The application and renewal fee for QRCs and QRC Interns will change from \$100 to \$140.

QRC interns only

- The date of the last rehabilitation update attended (if applicable).
- Certification completion date or estimated completion date for any certification in progress.

QRCs only

- The date of the last rehabilitation update attended.

Additional information for QRC firms and rehabilitation vendors

- An affirmation that each employee has attended the required Department of Labor and Industry (DLI) rehabilitation provider update session and orientation session as required.
- An affirmation that at least one office where the applicant will provide rehabilitation services is located in Minnesota or within 100 miles by road from the Minnesota border.
- An affirmation that staff requirements are met (included in text acknowledgements at the end of the form).
- The application and renewal fee for QRC firms and rehabilitation vendors will change from \$200 to \$280 per year.
- The electronic signature text has been updated to reflect the updates made to the form.
