Worksheet and Code Change Proposal Review:

Reviewed Code Change Proposals (CCP) to chapters 4-7 of the International Building Code.

- CCP 21.1 IBC 423.5.1 Storm Shelter Required Capacity: The TAG discussed the two options presented in the CCP and tabled the CCP for revision to option 1.
- CCP 22 IBC Table 506.2 Allowable Area: The TAG consensus is to support the CCP with modifications to allow sprinklered Group R-3 occupancies to have unlimited area, which is currently allowed Group R-3 occupancies, and to limit non-sprinkled Group R-3 occupancies to 4,500 sq. ft.
- CCP 23 IBC 602.3 Type III Construction: The proposal was withdrawn by proponent.
- CCP 88 IBC 705.2 Combustible projections: The TAG consensus is to support the CCP to clarify requirements for combustible projections.
- CCP 24 IBC 705.6 Exterior walls: The proposal was withdrawn by proponent.
- CCP 89 IBC 705.7.1 Floor assemblies: The TAG consensus is to support the CCP which adds a section to ensure supporting construction elements are protected as required.
- CCP 113 Minn. R. 1305.0707 Fire barrier continuity: The TAG consensus is to support the CCP with modifications to simplify the termination allowances for fire barriers.
- CCP 28 IBC 709.4.2 Smoke barriers at elevator lobbies: The TAG consensus is to support this change because it clarifies the termination requirements for a smoke barrier wall at an elevator lobby.
- CCP 29 IBC 713.13 Waste and line chute: The TAG tabled this proposal to review additional information on NFPA 82.

- CCP 30 IBC 714.4 Fire-resistance rated walls: The TAG tabled this proposal so the proponent could be present.
- CCP 90 IBC 714.5.2 Membrane penetrations: The proposal was withdrawn by proponent so this change could be presented/approved at the national code level prior to review by the TAG.
- CCP 91 IBC 714.5.4 Penetrations at smoke barriers: The TAG consensus is to support the CCP to clarify that only one of the criteria must be met and the extent of leakage requirements.
- CCP 92 IBC 716.2.2.3.2 Louvers: The TAG consensus to support with modifications. This code change clearly states that louvers are not permitted in accordance with this section.
- CCP 31 IBC 716.2.6.1 Fire door hardware and closers: The proposal was withdrawn by proponent.
- CCP 32 IBC 716.2.6.6 Smoke-activated doors: The proposal was withdrawn by proponent.
