TAG members will review the tables and sections and determine whether a code change proposal is needed.

2024 IEBC Section 905.4 Two-way communications systems

TAG members tabled this section to coordinate with Commercial Building TAG.

2024 IEBC Tables 1011.5, 1011.6, 1011.7 – Change of occupancy hazard categories

TAG members tabled discussion of the change occupancy hazard categories and will discuss code change proposals modifying the tables at the June 11 meeting.
