# **Worksheet and Code Change Proposal Review:**

### 1. Delegation Agreement Reform

- Current system is "all or nothing," making it difficult for smaller jurisdictions to qualify.
- Proposal: Create tiered delegation levels (QP1-QP4) to allow more flexibility and access.
- Goal: Match delegation levels to project complexity and official qualifications.

#### 2. Statutory Language Updates

- Plan review to be explicitly included in delegation agreements (previously only inspections).
- Remove "all" from "municipal agreement for all building projects" to avoid misinterpretation.
- Clarify language to support tiered delegation and plan review authority.

#### 3. Reserved Projects

- Proposal to include plan review in reserved project delegation.
- Reserved projects currently include simpler scopes (e.g., reroofing, HVAC replacement).
- Discussion on whether to expand or redefine reserved project types.

#### 4. Project Complexity Tiers (QP1-QP4)

- QP1 (Reserved): Minor projects (e.g., reroofing, siding, HVAC swaps).
- QP2: Assisted living (no dementia care), outpatient surgical centers, DOT facilities.
- QP3: K-12 schools, critical access hospitals, nursing homes.
- QP4: High-security prisons, large hospitals, complex state facilities.

## 5. Qualifications for Delegation

- Debate over requiring licensed professionals (engineers/architects) for higher-tier projects.
- Concerns about access and affordability for smaller jurisdictions.
- Suggestion: Allow retained professionals or certification-based alternatives.
- Emphasis on experience-based qualification over licensure alone.

#### 6. Plan Review & Structural Oversight

- DLI staff noted lack of structural review in many delegated projects.
- Proposal: Require structural review for certain tiers or project types.
- Discussion on whether non-engineers can be trained/certified to perform structural reviews.

#### 7. Qualification Process

- Current process seen as opaque and subjective.
- Suggestions: Develop objective criteria and written exams.
- Include practical assessments or scenario-based evaluations.
- Maintain some interview component for applied knowledge.
