Agenda items:

1. Call to order

- The meeting was called to order by Don Mullin at 1:30 p.m. Roll call was taken by Erin Larsen, and a quorum was declared.

2. Approval of agenda

- A motion was made, seconded, and carried to approve the Apprenticeship Advisory Board Meeting agenda for October 9, 2025.

3. Approval of drafted meeting minutes

- A motion was made, seconded, and approved for the July 17, 2025, board meeting minutes.
- A second motion was made, seconded, and approved for the August 22, 2025, Special Meeting board meeting minutes.

4. Greeting and Update

- Kate Perushek, Deputy Commissioner, Minnesota Department of Labor and Industry shared several updates:
 - Efforts are underway to raise awareness about suicide prevention in the construction industry. Funds will be allocated to address mental health needs within the construction sector.
 - Part of the initiative will include distributing grants. A new grant will soon be announced to support mental health programs within the construction industry.

5. Board member updates

- Don Mullin, Chair, shared information about how schools are looking for more information about apprenticeship and any efforts from DLI to share that information would be appreciated.
- Mary Berg reported efforts to develop dual enrollment options and teacher apprenticeship pathways for high school students.
- Tom Dicklich announced that DLI had certified Building Strong Communities as a recognized apprenticeship preparatory program.
- Norma Miller highlighted outreach efforts at high schools to get students interested in apprenticeship programs.
- Sarah Paul shared updates from North Branch, where students have been touring programs and earning credits toward future trade careers.
- Melissa Stachovich discussed upcoming partnerships with educational institutions, creating new opportunities for journeymen.
- Sophie Thaden updated the board on the Construction Careers Foundation's 20th anniversary celebration and shared plans for new school-based exploration initiatives.

6. New Program Spotlight

- Tim Wilson, Farm Education Manager, provided an overview of a new registered apprenticeship program at the Minnesota Landscape Arboretum.
 - The program requires 3,175 hours of on-the-job learning, totaling approximately three growing seasons

7. Apprenticeship Program Development

- Paul Nikstad, Senior Field Representative, Minnesota Department of labor and industry shared updates on program development.
- New Programs added:
 - Bergerson-Caswell, Inc. – Construction
 - Cirrus Aircraft – Manufacturing
 - Elder Circle – Healthcare
 - Otter Tail Power Company – Utilities
 - Blue Pine Works – Agriculture

8. Apprenticeship Program Compliance

- Jeremy Parker and Meghana Shroff, Senior Field Representatives presented an overview of program compliance.
- Compliance updates:
 - 72 reviews completed; 72 remaining
 - 75 programs with no apprentices have been cancelled or transferred
 - Field representatives continue to ensure on-the-job learning hours are distributed across work process schedule as part of the program review

9. Workforce System Alignment

- Gerri McGimpsey, Senior Field Representative, Minnesota Department of Labor and Industry, shared updates on alignment between registered apprenticeship and the workforce system.
 - Registered apprenticeship programs are automatically eligible to be included on the Eligible Training Provider List (ETPL)
 - Collaboration with US DOL and DEED on WIOA/ Registered Apprenticeship Program (RAP) co-enrollment has resulted in updated policies and procedures to streamline processes for registered apprenticeship sponsors

10. Apprenticeship Minnesota Update

- Erin Larsen, Director of Apprenticeship, Minnesota Department of Labor and Industry provided an update on registered apprenticeship programs:
 - Updated demographics
 - 12,119 active apprentices

- 28.7% people of color
- 8.2% women
- 4.9% veterans
- Program Updates:
 - National Apprentice Week is scheduled for April 26 to May 2, 2026
 - Apprenticeship Summit for sponsors is scheduled for April 27th, 2026, at the Carpenters Training Institute
- Upcoming Events
 - Construction Inclusion week will begin October 13-17, 2025
 - Apprenticeship Instructor Training Series
 - Apprenticeship Preparation Programs
 - Apprenticeship 101
- Clean Economy Grant
 - No new applicants/awards during the last quarter
- LEAP Grant
 - 16 applications received; maximum of \$100,000
 - 10 grants awarded
- Registered teacher apprenticeship Grant
 - Awards will be announced in November 2025
- Federal Updates
 - Remain under Interim Non-enforcement of Department's Equal Employment Opportunity in Apprenticeship Regulations at 29 CFR part 30
 - No additional updates on the Notice of Proposed Rule Making
