

## Window Cleaning Safety



- 30 Day public comment period is over on March 6<sup>th</sup>.
- SEIU 26 has concerns about not requiring roof anchors. DLI will be meeting with them on March 8 to discuss and negotiate final rule language to avoid new legislation.
- Still targeting this fall for implementation.
- DLI/CCLD will cluster changes to Window Cleaning and Adult Changing Facility requirements into a consolidated bulletin

## **Electric Vehicle Charging Facilities**

- Normal rulemaking. This will be incorporated into the NEXT MN Commercial Energy Code. Fall 2026.
- Language will also be incorporated into the Minnesota Electrical Code.
- The MR 1305 Commercial Building Code TAG will also consider other potential safety features for indoor charging.
- Coordinating with DPS.





#### 326B.118 ENERGY CODE.

The commissioner, in consultation with the Construction Codes Advisory Council, shall explore and review the availability and appropriateness of any model energy codes related to the construction of single one- and two-family residential buildings. In consultation with the council, the commissioner shall take steps to adopt the chosen code with all necessary and appropriate amendments.

The commissioner may not adopt all or part of a model energy code relating to the construction of residential buildings without research and analysis that addresses, at a minimum, air quality, building durability, moisture, enforcement, enforceability cost benefit, and liability. The research and analysis must be completed in cooperation with practitioners in residential construction and building science and an affirmative recommendation by the Construction Codes Advisory Council.

## **Rep. Rehm: Presenting HF3439 Residential EV Charging**

326B.106 subdivision 16: Electric vehicle charging. The code shall require a minimum number of electric vehicle ready spaces, electric vehicle capable spaces, and electric vehicle charging stations wither within or adjacent to new commercial and multi-family structures and all new residential buildings that provide on-site parking facilities. ential structures with fewer th

## Rep. Kraft: Presenting Residential Energy Code Reform

(g) Beginning in 2026, the commissioner shall act on the new model residential energy code by adopting each new published edition of the IECC or a more efficient standard. The residential energy code in effect in 2036 and thereafter must achieve an 80% reduction in annual energy consumption or greater, using the 2006 IECC Site EUI for Minnesota as published by the US DOE, Building Energy Codes Program as a baseline. The commissioner shall adopt residential energy codes from 2026 to 2036 that incrementally move toward achieving the 80% reduction in annual energy consumption, (continued)





#### Rep. Kraft: Presenting Residential Energy Code Reform

(continued) with each update achieving 15% of the difference in annual net energy consumption between the 80% target and the code effective on December 31, 2024. Requirements must be adopted such that electricity-only and mixed-fuel only buildings attain the same site energy use intensity (EUI<sub>site</sub>). By January 15 of the year following each new code adoption, the commissioner shall make a report on progress under this section to the legislative committees with jurisdiction over the energy code.


326B.106 subdivision 2 (b): Municipal **Enforcement.** If No later than Jan 1, 2030, a municipality that is not required by paragraph (a) to administer and enforce the State Building Code (SBC), the municipality may chose to administer and enforce the SBC within its jurisdiction by adopting must adopt the code by ordinance and must administer and enforce the SBC with in its jurisdiction. (continued)

## Rep. Kraft: HF 4241 Statewide Building Code Enforcement


(c): Except in a municipality which has by ordinance adopted the SBC within its jurisdiction, or in a municipality with a population less than 2,500, every new residential construction requiring a permit pursuant to Minnesota Rules, part 1300.0120, must be inspected by the commissioner for compliance with the SBC.

## Rep. Kraft: Presenting HF3351 Single Stairway Apartments

326B.106 subdivision 18: Minimum number of exit stairways. The commissioner shall adopt rules, using expedited rulemaking process in section 14.389, modifying the State Building Code to allow a single exit stairway to serve nontransient multifamily residential structures that have an occupiable floor or roof not more than 75 feet above the lowest level of fire department vehicle access.

### Rep. Kraft: Presenting HF3351 Single Stairway Apartments

The first floor of such buildings may be used for a purpose other than residential as long as that use is classified as a nonhazardous occupancy and is served by entrances that are separate from those serving the residential floors. These modifications must include consideration for adequate and available water supply for fire sprinkler systems, the presence and response time of a professional fire department, and any other provisions necessary to ensure public health, safety, and general welfare. These modifications must be made by July 1, 2026.
