Call to order: Vice Chair Elizabeth Alm

• Treatment parameters – Emily Bannister, medical consultant; Lisa Wichterman, medical policy specialist; Ethan Landy, Office of General Counsel

Emily Bannister led a discussion about the updates to the imaging treatment parameters. As discussed at past meetings, this has involved a review of the American College of Radiology (ACR) guidelines on lumbar imaging. The goal is to change the section to be based on the clinical scenario. Some of the current imaging modalities are not recommended; Bannister and DLI staff members are working with the ACR appropriateness criteria to revise. Bannister also noted this is only the lumbar treatment parameters and not for cervical or thoracic. Low back pain and low back injuries are the most common in workers' compensation claims.

Some outstanding questions are the use of plain films, how to define acute trauma and timing for MRIs.

Deborah Zurcher said chiropractors use The Clinical Compass and the Council on Chiropractic Guidelines and Practice Parameters (CCGPP) as guidelines for using X-rays. Matthew Monsein asked about the use of sitting MRI versus standing MRI techniques. He also mentioned flexion extension views. What would indications for use be?

Olson noted there can be different charges for every different view of an MRI.

Items for the next meeting - Alm and board

Courtney Mitchell asked about looking at traumatic brain injuries (TBI). Ethan Landy explaied the focus
now is to update the current rules. DLI will focus on lumbar treatment parameters now, but will get to
TBI.

Kuhlman asked if workers' compensation will start addressing long-COVID-19. Fairview has been trying
to collect data. Lisa Wichterman said the International Association of Industrial Accident Boards and
Commissions (IAIABC) has been discussing gathering that data and it is very difficult. She would welcome
data from the board to share at an coming meeting.
