### How to apply for a license

To apply for a license:

- 1. Visit <a href="https://ims.dli.mn.gov/ims/">https://ims.dli.mn.gov/ims/</a> (Chrome browser preferred)
- 2. Click "Continue as Guest"



3. Click "New License or Registration"



4. Click "Combative Sports"
