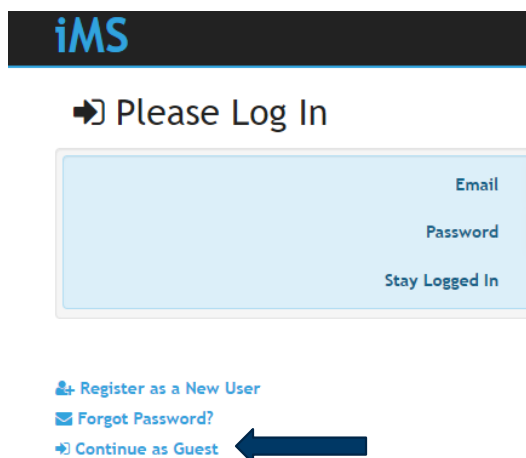


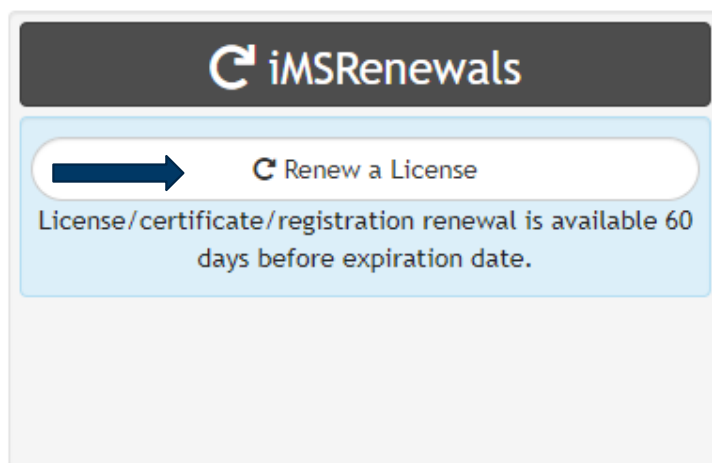
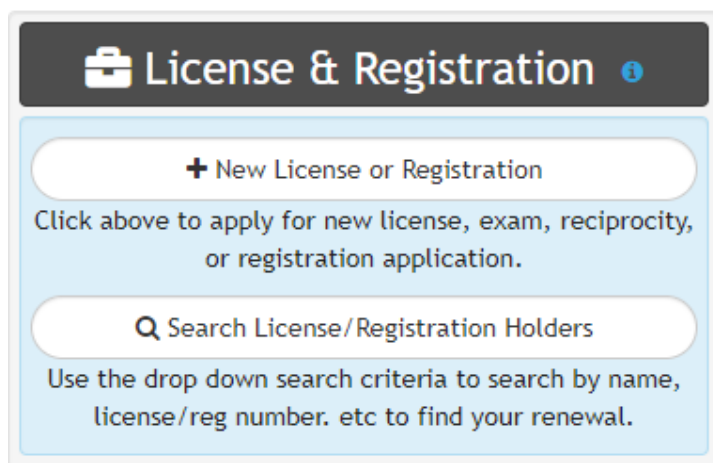
## How to renew a license

Revised April 26, 2023

1. Visit <https://ims.dli.mn.gov/ims/> (Chrome browser preferred)
2. Click "Continue as Guest."




3. Click "Renew a License."



- Enter your license number to find your renewal and click on "Search." **If you don't remember your license number, use the drop down search criteria to search by name and then select the correct record number.**

License/Registration No.  Keyboard TAB or click "\*" to add another 



Note: use the first two characters and the six numeral digits of your license, certificate or registration number to search. For example, EA123456, BC123456, PC123456 (no spaces or dashes).








