  - Committee identified chapters 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 15, 16, and 17 of the UPC as chapters for future committee review.
  - o Committee identified chapters 12, 13, and 14 as chapters not likely needing review.
  - Committee identified Appendices A, B, C, I, K, L, M, N, S for future review (will not review D, E, F, G, H, J, O, P, Q, R).
  - The agenda for the next meeting will be to review the RFA form, review chapters 1,2 and chapter 3 if time allows. In addition, the committee will be reviewing any tangential sections as needed.

The next meeting was scheduled for Jan. 3, 2024 @ 9:00 a.m. Twelve additional meetings were set for the first Wednesday of every month and will be held at DLI with a remote/phone option.
