### Call to order and roll call

Commissioner Nicole Blissenbach called the meeting to order at 9:35 a.m. A roll call was taken and a quorum was present.

### Approval of the minutes and agenda

Colin Beere moved to accept the April 20 agenda and the March 28 minutes. Hannah Alstead seconded the motion. A roll call vote was taken and the motion carried.

#### Announcements

Commissioner Blissenbach thanked the council members and stakeholders for their work in preparing the legislative package being presented today.

#### Agenda items

 Presentation and vote on proposals – Commissioner Blissenbach and DLI Office of General Counsel Ethan Landy, from the Department of Labor and Industry's (DLI's) Office of General Counsel, reviewed the finalized draft of the legislative proposals. Landy noted all changes would be effective Aug. 1, 2023.

Lauryn Schothorst noted the bill contained references to both calendar days and business days. For consistency, business representatives preferred all references be calendar days. Gary Thaden and Bernie Burnham agreed.

There were no further questions or revisions to the proposals. Burnham moved to accept the legislative proposals with the one change previously discussed. Schothorst seconded the motion. Burnham said the labor representatives were grateful for all the time and work that went into the proposals and appreciated everything the Department of Labor and Industry had done. Schothorst also thanked the council members, DLI staff members, the commissioner and the assistant commissioner for their work.

Thaden recommended the motion include authorization for the department and revisor's office to make small editorial changes without having to bring the proposals back before the council. He moved to

amend the proposal to include this recommendation. Burt Johnson seconded the amendment. A roll call vote was taken on both the original motion and the amendment; both motions carried.

Commissioner Blissenbach expressed her gratitude to the council members, stakeholders and department staff members for their work this session.

### **Other business**

A future meeting is not currently scheduled; there was discussion regarding scheduling a meeting at the end of May or early June.

## Adjournment

Thaden moved to adjourn the meeting and Burnham seconded. A roll call vote was taken and the motion carried. The meeting adjourned at 10:02 am.
